CALIFORNIA EDUCATION CODE: Suspension and Expulsion

A pupil may be suspended or expelled for acts that are enumerated in this section and related to school activity or attendance that occur at any time, including, but not limited to, any of the following: school day in the classroom of his or her child or ward The policy shall take into account reasonable factors that may prevent compliance
